2. School Report

- March All School Meeting Read Across America Theme. Students from different grade levels got to participate in the meeting.
- Getting ready for state testing Forward, ACT, PreACT
 - Testing starts in April
- School counselor is out on leave indefinitely Debra and Jim have been completing the duties of the school counselor
- ECVS meets once a month to discuss students who aren't meeting attendance requirements or having a difficult time adjusting to ECVS

4. "2023-24" Update

- In 2023-2024, all ECVS K-12 curriculum will be Pearson.
- Shift from 4 classrooms (K-1, 2-3, 4-5, 6-7) to 2 classrooms (K-2 and 3-6).
- The Pearson-only curriculum model should be a more sustainable for multiple reasons.
 - ECASD curriculum requires training on many of the ECASD curricular materials. This is a very big challenge because each ECVS teacher does not have a colleague from ECVS teaching the same grade level. Using Pearson curriculum means the training can come from Pearson's built-in training model and does not rely on ECASD-trained teachers transferring from brick-and-mortar schools to ECVS.
 - Pearson curriculum is designed for virtual programming. ECASD curriculum is not. This will allow for more asynchronous instruction, which provides more flexibility for families. As I have

- researched other virtual schools, this flexibility is one of the big reasons families choose virtual schooling. I know we are planning to survey our families about why they choose ECVS. We will continue to learn from family voices as we adjust our programming in the future.
- With Pearson in grades K-3, there will be no transition from one curriculum to another as students progress through ECVS grade levels.
- As the Governance Board has worked on the school's identity, we now have a clear focus on Pearson K-12. This is similar to what Appleton has successfully done.
- This impacts the budget due to cost for Pearson enrollment and training fees.
- Each current ECVS staff member is guaranteed a position with ECASD. With the addition and removal of FTE at positions, there are several shifts that are going to take place.
