1. History of the Committee

Pete Riley and Todd Johnson brought the new members up to speed by sharing the Board's goals, Charge of the committee, information gathered at the Innovation Conference and work done thus far.

2. Draft Policy and September 28 Board Presentation

The committee reviewed a draft policy that incorporated some of the same language from Board Policy 331, Charter School Guidelines. It was suggested to present the draft policy to the Policy and Governance Committee for review.

Tim Leibham presented the Development of Innovation Zones (PowerPoint)

- Educational Opportunities
- Governance & Structure
- Budget & Funding
- Proposal Process
- Performance Agreement
- Dissolving a Performance Agreement
- Transition Process of Innovation to Improvement

The committee discussed the structure of the program. It would need to separate from the Teaching & Learning Department. This is how we want to structure our program, methodologies, etc. Once that happens, they are free to be fully autonomous from other staff development. They would need some sort of supervision, but fundamentally they would be their own entity. Ultimately, the Board would approve for it to function.

Tim Leibham shared some of the performance agreements are quite lengthy. This could squelch the desire to implement this. Rich Spindler suggested presenting the PowerPoint at the September 28 Board Meeting, and then ask for approval to refer the draft policy to the Policy and Governance Committee.

Is anyone doing anything right now that is outside the norm that has helped close the reading or math gap? Co-teaching could be an example. Also, some teachers are incorporating Social Studies within Reading. It was suggested to perhaps add an additional slide to include autonomies.

The committee members discussed some of the cons:

- Reallocation of funds/cost
- Acceptance of risk and failure
- Difficulty with acceptance of autonomies
- Tensions between innovation zones and conventional programs
- Staff tensions
- Fear of change and unknown (is it fear of unknown, or fear of giving up what is known?)

Gail Halmstad shared the education department at UWEC is initiating a pilot (focus will be on reading) at Robbins Elementary and some schools in Chippewa Falls. If they get a specific grant, they plan to work with Augusta and Cornell School Districts as well. Evidence-based rules would be part of the application process.

Tim Leibham, Melissa Greer and Derick Black will meet prior to the September 28 meeting to review the PowerPoint.
