## **Referendum Committee Report (GC-5)**

Commissioner Bica provided a Referendum Committee report. The committee met on December 7 to discuss the timeline of the referendum. She stated that they also discussed items from the recent work session.

#### Legislative Liaison

Commissioner Farrar provided a Legislative update including provisional teaching licenses for paraprofessionals currently working, removing liabilities from staff that possess 'obscene materials,' and Full Time Open Enrollment acceptance for children of teachers working in a district outside their resident school district. Governor Evers signed Assembly Bill 109 into law which requires students to complete a half credit of personal financial literacy in order to graduate from high school. The Assembly Committee on Local Government held a public hearing on Assembly Bill 723. This bill would require that school boards solicit bids and award a public works contract to the lowest bidder if the estimated cost of a contract exceeds \$150,000 and the contract is for the construction, repair, remodeling, or improvement of a public-school building or for the furnishing of supplies or materials. WASB opposes AB 723 and urges school leaders to contact state legislators.

## **Key Communicators Group Update**

Commissioner Farrar also provided an update on the Key Communicators Group conversation on ELA and College and Career Readiness. Members were glad that ECASD is ahead of Act 20 in implementing research-supported literacy instruction methods. The group hopes to take more steps to get more students more resources for when they arrive at school.
