3. School Report – Jim Schmitt

- There is no FAC update today because there has not been a FAC meeting for the 2023-2024 school year.

5. Pearson Update

Pearson is the platform that ECVS uses to deliver content to virtual learners.

- Pearson contacted ECASD in June to inform us that they are planning to add another academy to Wisconsin similar to Connections Academy to reach additional students.
- Pearson will present at the school board meeting on October 2nd to propose that ECASD will sponsor this additional Connections Academy for Wisconsin. They will not vote on this at this meeting.
 - Proposing a Careers Connections Academy how is this different than Connections Academy?
 - o New ECASD school in addition to the existing schools
 - This is not connected to ECVS
 - ECASD can benefit from funding for students and there could be a discount for Pearson enrollment for ECVS
 - This would be similar to Appleton who has a Connections Academy and a separate Appleton eSchool
 - O How will they reach students in our area that we aren't able to reach?
 - How will this be differentiated for families in the area? How will they be informed about making the decision that is best for them?
 - o This academy is ALL virtual there are no in-person teachers or a building based in Eau Claire.
 - Invite superintendent to future meeting to debrief and discuss the consideration of the Connections Academy and ECVS
 - Will students be able to attend the brick-and-mortar ECASD schools through the Career Connections Academy
