- 2. Annual Meeting: Enrollment and School Composition Jim Schmitt and Debra Nemitz
 - K 12 students enrolled in ECVS
 - o Male 46
 - o Female 67
 - Special Education 13
 - American Indian 2
 - Asian 11
 - o Black − 16
 - Native Hawaiian 5
 - o White 95
 - Total 113 students
 - o This is lower enrollment than last year which is predicted as schools recover from COVID
 - o October 2022 Enrollment and School Composition
 - 9 students are on the waiting list to be enrolled for Semester 2
 - Some students have gone back to their home schools mostly secondary students
 - Student activity is monitored weekly through the LMS a call is made to families whose students are failing to participate.
 - The orientation course has been a good measure for success
 - Counselors should participate in the ECVS orientation course so they are better equipped to assist virtual students
 - Counselor feels as though they can address student needs effectively
 - ECVS has students from different districts across the state
 - o 89 residents
 - o 24 non-residents
 - o Families may be in our boundaries but not choose ECVS because:
 - Familiarity

- College courses offered
- There are 112 students who have gone outside of ECVS boundaries to attend other virtual schools
- Teachers are enthused to work on the marketing for the school
 - There is a Facebook account for the school
 - Teachers met and came up with a marketing plan
 - A new video will be made for marketing purposes
 - o "Day in the life"
- Parents are looking for:
 - Public school
 - Music, art, and Phy. Ed. offering Sam Davey, Locust Lane, and Lakeshore MAPE teachers teach the ECVS K – 5 students on a rotation
 - Supplies are available to be picked up for mailed
 - Special Education support
 - Live lessons
 - Flexibility
 - o Field Trips
 - 2nd grade went to Beaver Creek
 - Possible future trip to the Public Library in November
- Other benefits of ECVS
 - Offer up to 2 in-person classes
 - Can join a club if taking a in-person course
 - o Ability to do an in-person sports
 - CVTC academies and iReady
 - Credit Recovery will be available soon during the school year and the summer
 - Students are able to "test-out" of subjects to move on to other credits for placement
