The meeting was called to order by Margot at 4:34 PM.

• Public Comment

Laura Miller spoke about concerns regarding capacity issues at North High School.

Approval of Minutes

The minutes from September 23, 2021 were reviewed.

Caro made a motion to approve the September 23, 2021 minutes. The motion was seconded by Alicia. Motion passed by unanimous voice vote.

• Memorial Cafeteria Addition Discussion

 Kim discussed whether the Memorial cafeteria addition should be considered through capital improvement or Demographic, Trends & Facility Planning committee based on scope of the project.

Margot made a motion to move the high school memorial cafeteria addition renovation decision to the capital improvement budget through the Facilities Department. Caro seconded the motion. Motion passed by unanimous voice vote.

• 2021-22 Enrollment Trends

 Kim discussed the actual 2021-22 total actual enrollment trends compared to the APL projections published in February 2021, and showed that the actual enrollment most closely align with the baseline APL projections.

Elementary School Enrollment Trends and Recommendation Review

- Kim reviewed the actual 2021-22 enrollment numbers and the APL baseline projections at the elementary school level.
- Margot reviewed the previous elementary school renovation recommendations and opened it up to the group to discuss those recommendations based on our most current enrollment data.
- The group discussed the current facility needs of elementary schools based on the updated 2021-22 enrollment numbers and APL projections.

Margot made a motion to amend the committee's current elementary school recommendations to the Board by prioritizing the additions to Meadowview and Putnam Heights, but if both are not financially feasible, prioritize only the Putnam Heights renovation. The motion was seconded by Caro. Motion passed by unanimous voice vote.

Middle School Enrollment Trends

 Kim reviewed the actual 2021-22 enrollment numbers and the APL baseline projections at the middle school level. Group discussion followed.

• High School Enrollment Trends

Kim reviewed the actual 2021-22 enrollment numbers and the APL projections at the high school level.
The group discussed how these projections align with the committee's high school expansion recommendations.

Presentation to the Board

- Kim discussed what recommendations would be taken to the Board:
 - High school expansion recommendations
 - MHS cafeteria expansion to be moved to capital improvement budget
 - Modification to previous elementary recommendations
 - Renewing the APL study every 5 years
