### Approval of Previous Minutes

• The minutes from May 11<sup>th</sup> were reviewed.

Marquell Johnson made a motion to approve the May 11, 2022 minutes. The motion was seconded by Lori Bica. Motion passed by unanimous voice vote.

#### Committee Formation

 The group reviewed and edited GC-5 for new wording for the Referendum Committee. There was discussion about future funding for school districts and the importance of having regular budget conversations in the regular board meetings.

#### • Referendum Work

- Mike reached out to seven other districts to see about dedicated grant writers and shared his findings with the group. They discussed what this could look like for ECASD.
- There were questions from the committee to Baird about referendums. Abby shared some of the findings.
- Abby reviewed some information from the Facility Committee's options and compared them to Demo & Trends current recommendations. She continued the conversation to share additional facility options for South and Memorial.

- Annexation for Meadowview good selling point city population growth not just moving people around
- It is important to share that we are prepping buildings to absorb growth more easily (Putnam)
