Job Summary

The Seasonal Worker Mower works seasonally from approximately April through October to assist with district building lawn and yard maintenance. This position works under the supervision of the General Manager - Operations and works at various buildings throughout the district.

Essential Job Functions

- Operates large lawn mowing equipment
- Operates dump trucks and trailers, skid steers, tool cats.
- Operates chainsaws and other power and hand tools to maintain appearance of bushes, trees, shrubs.
- Operates push mowers, weed whackers, and edge trimmers for lawn maintenance.
- Transports trailers of equipment to and from job sites and back trailers into sites as needed.

Ancillary Job Functions

- Performs other related duties as assigned.

Required Qualifications – Required qualifications to effectively perform the job at the time of hire. An equivalent combination of education, training, and experience will be considered. Additional requirements and/or substitutions may be requested and require the approval of HR.

- Valid Driver's License
- 18 years of age or older.
- Working knowledge of various lawn mowing equipment and heavy machinery.
- Experience with landscaping and related equipment.

Preferred Qualifications – Highly desired education, training, and/or experience that may be helpful in performing the job, if applicable.

- CDL

Knowledge, Skills, and Abilities – May be representative, but not all-inclusive, of those commonly associated with this position.



- Ability to follow written and oral instructions.
- Ability to interact in a courteous, friendly, respectful, honest and professional manner with the public and staff at all levels.
- Ability to work independently and in a team environment without direct supervision.
- Ability to safely pull and back up trailers.
- Demonstrates an understanding and use of equitable and culturally responsive practices.

Work Environment – Environmental or atmospheric conditions commonly associated with the performance of the functions of this job.

- May be exposed to hot and humid conditions, loud noises, and sharp tools, and inclement weather conditions.

Physical Requirements – The physical demands described below are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform essential functions.
